



Yuppie Dog Services Agreement

This is an Agreement between **Yuppie Dog, LLC**, a registered Texas limited liability corporation doing business as Yuppie Dog Daycare & Grooming and the Owner/Guardian whose name is:_____. Following are the terms of service for the stay of the Owner/Guardian's Pet (name) _____ (the Pet) as a guest of Yuppie Dog:

1. Owner/Guardian certifies that their dog(s) is/are in good health and have not been ill with any communicable diseases or parasites in the last 30 days, and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
2. Owner/Guardian acknowledges and is aware that the employees of Yuppie Dog, LLC are not veterinarians and do not have backgrounds in animal medicine and are not expected to diagnose or detect illness in our guests.
3. Owner/Guardian also recognizes that vaccines, although effective in most cases, do not completely protect the boarded pets from contagious diseases.
4. While Yuppie Dog will always act with diligence and professionalism in bestowing services to pets under our care, Yuppie cannot prevent all accidents or injuries that might occur during the course of a normal stay or during periods or group playtime activities.
5. Owner/Guardian agrees to be solely responsible for any and all acts or behavior of the Pet while in care of Yuppie Dog, including payment of costs of injury to staff or other animals or damage to facilities caused by the Pet.
6. A confirmed reservation is a reservation that is booked with a valid credit card and proof of current vaccines for the applicable Pet is on file. Reservations for more than 15 days require a 50% deposit at the time of booking. Our cancellation policy is 24 hrs prior to check-in for non-peak periods and 5 days for peak periods. Peak periods are determined as follows:
 - a. Fourth of July (July 3-6)
 - b. Thanksgiving (November 26-30)
 - c. Christmas (December 23-27)
 - d. New Years (December 30-January 2)

If a cancellation is not made within the days mentioned above, it will be considered a "no show." Cancellations not received on time, or no-shows will be charged (1) one night to the credit card on file.

7. Owner/Guardian agrees to pay the pet care service and hotel rate in effect on the date Pet is checked into Yuppie Dog and to pay for any additional services requested when the Pet checks out.
8. Owner/Guardian agrees that the Pet shall not leave the facility until all charges due are paid or proper payment arrangement is agreed upon by both parties.
9. If any unpaid balance remains due after (30) thirty days, Yuppie Dog will impose interest at a rate of 1.5% per month until paid.
10. Owner/Guardian agrees to comply with the published Our Rules of Yuppie Dog which may be revised from time to time or without prior written notice to the Owner/Guardian.
